Charges for damages:

 Small: \$10 to \$25 Large/non-repairable: Replacement cost
- 3) Rip/tear/hole in **tent floor, body, rain fly**
 Small: \$10 to \$25 Large/non-repairable: Replacement cost
- 4) Broken Zipper..... \$25
- 5) Lost, broken or bent **stakes**..... \$1
- 6) Lost **ground cloth**..... \$5
- 7) Lost or non-repairable poles
 - 2-person outfitter.....\$25 each pole
